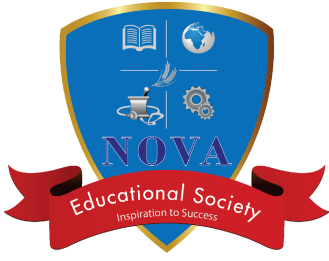

5. I am aware that as per Hon'ble Supreme Court orders, ragging in any form whatsoever is totally banned and criminal proceedings will be lodged in case I am found involved in instances of ragging. I understand that this will result in my rustication from the college and I will not be able to take admission anywhere in India.
6. I hereby declare that I have never been involved in or punished for any case of indiscipline during my school or college career. There is no inquiry pending against me with the school/college/police/other authorities of the state to which I belong or any other state where I resided at any time.
7. I am aware that I should be regular and punctual in attending classes and Shortage of Attendance below 75% in aggregate of all the subjects shall in No case be tolerated.
8. I understood that Students should neither leave the class rooms nor the campus without the prior permission of the Principal / HOD/ Class Counsellor during working hours.

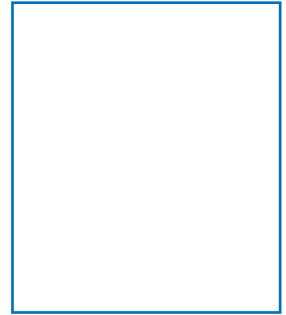

FORM - V

HOSTEL RULES & REGULATIONS

1. Ragging is strictly prohibited in any form; if anybody found guilty, severe action will be taken.
2. Students are prohibited from consuming alcohol, narcotic drugs or any intoxicating substance in the hostel premises.
3. All visitors to the hostel including parents/guardian will have to make necessary entries in the visitors book available at the hostel entrance with the security guard.
4. Students should not keep any unauthorized property and unauthorized guests in his/her room.
5. No person, either guest or otherwise shall be permitted to stay overnight in any part of the hostel. In case, guest want to stay overnight in the hostel, he/she shall take permission from principal.
6. All students are expected to be back in the hostel by 6.00 PM, if any student wishes to be away, he/she should take permission from the hostel authority showing appropriate reasons.
7. Students are responsible for the safekeeping of their valuables. Students should arrange their own locks and should take proper care of their belongings.
8. Students are not allowed to organize any group / religious activities in their room.
9. Students should handle hostel equipment, furniture, mess property with care and not abuse or tamper with it. in case of contrary behaviour applicable , fine will be charged by the hostel management.
10. Students have to use water and electricity judiciously. If any electrical appliances like fan, tube, etc., are found Switched ON in the absence of students at their rooms, fine of Rs.1000 /- Day will be charged by hostel authorities.
11. Garbage and wastage should only be put at garbage box available nearby in the hostel premises.
12. Students during their stay in the hostel will be governed by rules framed by the hostel management.
13. Students will not enter rooms of other students without permission of the inmates.
14. Every case of illness and accident must be reported immediately to the hostel authorities.
15. No function or celebration shall be organized at hostel premises except with the permission of the Principal.
16. Allotment of room furniture etc. will be entirely at the discretion of the Warden and no complaint in this regard will be entertained.
17. Any complaint from the neighbours /society against students will result in strict action.
18. Hostel accommodation (room) can be changed by the management if found necessary at any point of time.
19. Students indulging in use of abusive and threatening language, physical fights, use of force to get any unfair act accomplished, etc. will be punished. Further, they are liable to be expelled from the hostel/ Institute immediately.

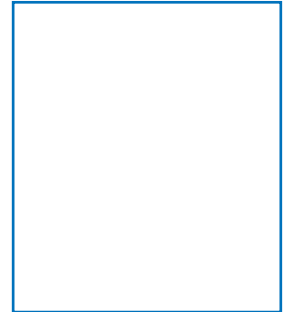

TRANSPORTATION RULES & REGULATIONS

- 1) Bus Fee should be paid in advance for the complete academic year before the commencement of classes. Bus fee is for the complete academic year only.
- 2) Bus Fee once paid will not be refunded.
- 3) Bus admission cannot be cancelled in the middle of the year.
- 4) Students must carry bus pass everyday. Without bus pass student cannot travel in the Bus.
- 5) If students are to travel in bus without pass they will be fined Rs. 1000/- per day.
- 6) The Student / Faculty must maintain bus timings. The bus will not wait for anybody. If made to wait the person will be fined with Rs. 500/- per day.
- 7) Proper discipline is to maintained in the bus.
- 8) Students must note that ragging in any form is a punishable offence.
- 9) If student / faculty is found causing damage to the property of the bus such person shall be fined Rs. 5000/-.
- 10) If student is not travelling by Bus on a particular day it must be informed to the Bus in - charge without fail, else action will be taken.
- 11) In case of violation of these rules and regulations Management decision shall be binding on the students
